IPM statement

It is the goal of Pierce Joint Unified School District to implement IPM by focusing on long-term prevention or suppression of pests through accurate pest identification, by frequent monitoring for pest presence, by applying appropriate action levels, and by making the habitat less conducive to pests using sanitation and mechanical and physical controls. Pesticides that are effective will be used in a manner that minimizes risks to people, property, and the environment, and only after other options have been shown ineffective.

We strive to create and sustain a "pest-free" learning environment and to use the least intrusive methods to remove and eradicate pests that supports student health and safety.

Pest identification, monitoring and inspection

Pest Identification is done by: PJUSD Staff & Stevenson Pest Control/ Caddy Shack Roden Services

Monitoring and inspecting for pests and conditions that lead to pest problems are done regularly by PJUSD Maint., grounds, custodians and kitchen staff and results are communicated to the IPM Coordinator.
(Example: District staff title, e.g. Maintenance staff)

Specific information about monitoring and inspecting for pests, such as locations, times, or techniques include:
(Example: Sticky monitoring boards are placed in the kitchen and are checked weekly by custodial staff.)

Sticky monitoring boards are placed in kitchens and storage areas which are checked daily by kitchen & custodian staff. Garden areas are monitored by grounds and maintenance staff for ants and other subterranean pests. All roof attic areas are to be blocked to prevent nesting of pigeons or other birds/bats.

Chemical pest management practices

- Reports of all pesticides applied by school district staff during the calendar year, except pesticides exempt¹ from HSA recordkeeping, are submitted to the Department of Pesticide Regulation at least annually, by January 30 of the following year, using the form provided at www.cdpr.ca.gov/schoolipm. (Education Code Section 16711)

(Education Code Section 17610.5)
